

## SCHOOL REPORT.

#### FELLOW CITIZENS:

It becomes our duty to submit our annual report at the end of the school year, whether it is well or ill received, and we should enter upon this duty with more cheerfulness, if we had full assurance that out people would profit by what we say to them, but we are aware that few will read, and some who do read will do so to criticise or to forget; therefore we use brevity, and trust those who do read will remember that it has been but a few years since we consolidated our schools, reducing the number of schools to four, and adopted the plan of having three terms in a year, of ten weeks each, instead of running seven schools two terms of eight or ten weeks, as our funds would afford. We are sorry to see that there is such a want of appreciation of the worth of school privileges, as to suffer any part of a school term to be unimproved by the children, and yet we recommend the keeping of our schools up to a proper standard for the benefit of those who do and will improve them. The chronic habit that some of our people have acquired, of fault-finding, will always fail to make good schools. We are often asked who is to teach in this or that school. The question is answered, and the next suggestion is, the school will be worthless, and the only reason that can be assigned for such a state of things is because we make them worth less than they should be. The success of our schools has been, the past year, all that we could expect under the circumstances. We cannot expect to get the best teachers in all cases, because we cannot have the first choice for the wages we pay, and again we are liable to be disappointed in the teachers we employ. But we confidently say that we believe we have been as fortunate as the people in other towns in procuring good teachers. We have learned from experience that teachers of great energy and executive ability are needed in our mixed schools, and nothing short of untiring devotion to the work will succeed well. Sluggishness in a teacher will always abate the energies of scholars. Our energetic teachers give us live schools, and turn out good scholars, and such has been the character of most of our teachers. We wish we could say the same of all.
